# VIDEO BLOOD PRESSURE VISITS: TAKING THE PRESSURE OFF PATIENTS

### **Challenge**

Patients with abnormal blood pressure require routine blood-pressure monitoring, and at times, may require challenging or inconvenient travel for in-person clinical care. Consequently, patients may neglect their appointments altogether; and therefore not receive the necessary follow-up to assess ongoing lifestyle or medication interventions as a part of the long-term treatment plan. This may further exacerbate the patients' condition.

#### **Innovation**

Dr. Margaret Carrico, Virtual Care Lead for Primary Care, and RN Cortney Frosch, Virtual Care Integration Lead for Primary Care, identified an opportunity to use VA Video Connect for these important visits, making follow-up accessible and engaging for patients. Video Blood Pressure (BP) Visits allow patients to replace the in-person follow-up visit with a virtual visit.

Video BP Visits eliminate concerns about unnecessary exposure to potential communicable infection(s); and save the patient the time and cost of travel, the stress of finding parking, the cost of childcare or time off work, and the copay for the visit.

Through the Diffusion of Excellence, RN Frosch and Dr. Carrico spread the innovation to the VA Boston Healthcare System and the Gulf Coast Veterans Health Care System. Video BP Visits can be implemented in as little as one month's time!

#### **How It Works**

Patients in need of a blood pressure follow-up visit are issued a VA blood pressure cuff, and a VA Video Connect (VVC) visit is scheduled. Once scheduled, an email is sent to both the member of the clinical team and the patient with an online link to a secure Virtual Medical Room (VMR). The patient can access VVC through their personal computer, mobile device, or tablet!

During the visit, the patient uses the cuff to measure their blood pressure. The patient then shows the results to the clinician, holding the monitor screen directly in front of the camera. As with an in-person visit, the clinical team evaluates the need for any changes to the care plan and completes the documentation and the encounter as usual. It is that easy!

### **Impact**

More than 20 facilities across the VA have adopted Video Blood Pressure (BP), demonstrating that Video BP Visits are an achievable introduction to virtual clinical care. Video BP Visits have the ability to enhance care in a number of ways impactful to the Veteran, the clinical team, and the VA health system. Patients are less likely to skip their visits, improving adherence to care plans and providing an opportunity for critical follow-up or care plan modification. As a result, continuity of care is preserved and no-show rates for follow-up visits may improve, allowing for more effective utilization of clinical resources.

Video BP Visits provide an opportunity to expand VVC utilization for clinicians and patients – building the foundation for a robust telehealth program at your local facility.
